### STUDENT FEES

\*Annual Fees include a Curriculum fee of \$300 per student which includes the cost of materials and administrative costs. Also included, is a Classroom Enhancement fee of \$150 per student which helps cover classroom learning manipulatives, supplies, teacher classroom funds and classroom enhancements.

### TUITION DISCOUNTS

10% Discount per additional child.  
\$250 Discount for pay in full, one installment payment by July 1st.  
\$100 Discount for pay in full, two installment payments by July 1st and December 1st.

### PAYMENT INFORMATION

Payments are due on the 1st and can be processed through the parent portal available on our school website. A 1% tuition insurance premium will be assessed for each 10-month installment plan and requires a form of payment on file. Payments which are not received by the due date will be automatically charged on the 15th of the month unless an arrangement has been made with the billing department.  
Late Fee Policy: Your account will be charged a \$25.00 per month late fee on all outstanding balances after the 15<sup>th</sup> of the month.

### FINANCIAL AID

You must first apply to our school and be accepted to be considered for aid.  
Upon acceptance, a financial aid application can be accessed through our website and is administered through FACTS. Application deadline is March 1st.
